5. No of email addresses to deploy to and in an excel format

NINDOO PROCESS

HOW TO GET STARTED?

1. Client completes Nindoo Subscription Agreement and submits to Nindoo (by email, fax or post)
2. Nindoo Accounts Department will raise an Invoice and submit to the Client
3. Client forwards their required images (.bmp or .png format only) that they wish to have included in their Nindoo to Nindoo (by email)
4. Nindoo will liaise and establish with the Client what they want to achieve with their Nindoo, whether it be an invitation to an event or a standard daily Nindoo
5. Nindoo then sends all images to the Nindoo Creativity Department to create the Nindoo or Nindoo's
6. If Client requires a video to be included into a HTML Page, the Client must send the video to Nindoo in Quicktime format. Nindoo will then compress the video and embed it into the HTML Page
7. A Nindoo is constructed by the Nindoo Creativity Department, and quality checked by our Creative Manager. A further quality check is completed by the Nindoo QA Department. The Nindoo is then sent to the Client for approval
8. All changes to Nindoos or new Nindoo enquiries are always directed by the Client to support@nindoo.com.au who will in turn organize the necessary changes
9. Final Client approval is obtained
10. Nindoo will deploy the Client Nindoo in accordance with the Client instruction

NOTE TO ALL CLIENTS:

- o All images submitted to Nindoo must be in either .bmp or .png format only
- o All videos submitted to Nindoo must be in Quicktime format only
